THIS WEEK IN WASHINGTON: NMHC Stops Inclusion of Pay-Fors in Democrats' Reconciliation Package, FCC Targets Industry with New Rule

As August recess approaches, members of Congress are working to pass key legislation in an effort to shape the outcome of the November election. The Administration is also continuing its regulatory reform efforts—with action taking place at the FCC.

What We're Watching:

- [Tax pay-fors targeting multifamily were back on the table](#) as part of the reconciliation package, but NMHC advocacy efforts stopped them from moving forward—as of this writing. However, with the reconciliation package still up in the air, NMHC remains engaged to ensure they aren't brought back into the fold.
- [A new FCC proposal misrepresents current industry practices](#) and could significantly impact industry operations. [NMHC set the record straight](#) that property owners do not engage in digital discrimination and are strong proponents of broadband access to multifamily residents.
