SECTION 8 REFORM WITHIN REACH

NMHC has long advocated for full funding of the Section 8 Housing Voucher Choice Program, but only if meaningful reforms were made to make it easier for housing providers to rent to voucher holders.

We are happy to share that our years of advocacy efforts have helped in creating a bipartisan measure to streamline the program and make it more palatable to our members. If passed, the legislation would:

- Permit voucher administrators to provide signing bonuses to landlords in low-poverty areas;
- Help with security deposits;
- Reduce inspection delays;
- Expand the use of neighborhood-specific data to set rental subsidies.

This is a decades-long effort, and although the next steps for the legislation are unclear, it's a victory just to get it on the radar of lawmakers and to get a bipartisan bill on their agenda. For the full background on our efforts in this space, [click here](#).
