CFPB ISSUES RULE REQUIRING NOTICE OF EVICTION PROTECTIONS

The Consumer Financial Protection Bureau (CFPB) [issued an interim final rule](#) that requires "debt collectors" to provide written notice to residents of their rights under the CDC eviction moratorium. The applicability of this rule depends on numerous factors, but property managers, attorneys and others involved in evictions may be subject to the new requirement if they are categorized as a debt collector. NMHC encourages members to review the sample disclosure language provided by the CFPB and consult with legal counsel to learn more about individual compliance obligations.

The NMHC Research Foundation commissioned new research from the Brookings Metropolitan Policy Program to examine the housing challenges and policies of other developed nations for new insights. The report highlights specific strategies and learnings from the United Kingdom, Germany, France, Spain and Japan. Republicans Release \$568 Billion Infrastructure Package

In response to President Biden's proposed \$2 trillion "American Jobs Plan" infrastructure package, Republican Senators have released their counteroffer—a \$568 billion proposal with a much narrower scope.

Notably, housing-specific provisions have not yet been included as part of their package. However, many of the proposed provisions will have a direct impact on multifamily development and the communities in which we build. Both the existing building supply and new apartment development are directly dependent on the condition and availability of suitable transportation options, reliable water and utility infrastructure and broadband and telecommunications services. NMHC HIGHLIGHTS RENTAL ASSISTANCE SOLUTIONS TO BIDEN ADMINISTRATION

This week, NMHC members and staff led a real estate coalition discussion with the Biden Administration to discuss the challenges accompanying the allocation of Emergency Rental Assistance Program (ERAP) funds to states and localities. During the White House call, NMHC members **Taryn Lewis** of BH Management, **Jeff Brodsky** of Related Companies and **Andrea Vinstra** and **Diane Taylor** of the Sterling Group explained their experiences securing ERAP funding to Administration staffers from the Executive Office of the President, the Department of Housing and Urban Development and the Treasury Department.

STUDY SHOWS REPEALING STEPPED-UP BASIS WOULD DAMAGE THE ECONOMY

NMHC, as part of a coalition comprised of 60 organizations, commissioned a new report by Ernst & Young that finds repealing the step-up in basis tax provision would damage the gross domestic product (GDP) and significantly decrease job creation. "Repealing stepped-up basis is not a free lunch for those looking to generate tax revenue and would have significant consequences in the multifamily marketplace," said NMHC **Doug Bibby** in the report press release. "Absent stepped-up basis, heirs could inherit an apartment property with a small amount basis and possibly sizable debt."

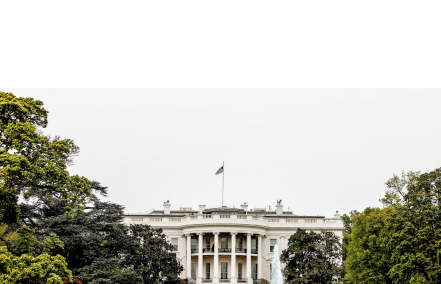
JOIN NMHC FOR INAUGURAL COMMERCIAL FACILITIES CYBER WORKING GROUP MEETING

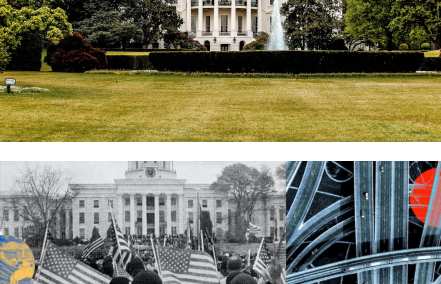

[BIDEN EYEING TAX RATE AS HIGH AS 43.4% IN NEXT ECONOMIC PACKAGE](#)

To pay for the recently proposed "American Jobs Plan," President Biden will reportedly introduce a plan that would almost double the capital gains tax rate to 39.6 percent – an increase from the current 20 percent rate.

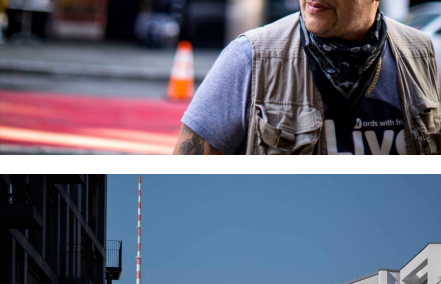
[CALIFORNIA NEEDS MORE AFFORDABLE HOMES. THIS UNION STANDS IN THE WAY.](#)

Berlin enacted state rent control legislation in February of last year. However, their courts have now ruled that their rent cap is, in fact, illegal.

The sponsors of the Illinois rent control ban in Illinois tweaked their original proposal. The revised legislation now puts the onus on local municipalities to decide whether or not to lift the ban.

HUD WITHDRAWS PROPOSED RULE THAT WOULD HAVE AMENDED 'EQUAL ACCESS RULE'

Following the Trump Administration's move to roll back transgender protections included under the Equal Access Rule, HUD Secretary Marcia Fudge announced this week that the Biden Administration will withdraw said proposed rule. The Equal Access Rule ensures that all individuals – regardless of sexual orientation or gender identity – have equal access to the HUD programs, shelters, other buildings and facilities, benefits, services and accommodations.
